What will your donation provide?

Your donation will be used for the care of all cats who are accommodated in the SPCA cattery and for the maintenance of the nursery during the year.

As an acknowledgement, we will place a plaque with your message (e.g. "In Memory of") on the cattery door and on SPCA's website.

You will receive quarterly photographs of some cats who passed through the nursery on their way to a new & loving home, as well as a small write-up on each.

How much does it cost?

The cattery costs an estimated \$2,500.00 per month – for upkeep, food, water, toys, bed and litter... all the things stray or unwanted kittens need.

To be a sole sponsor of the cattery for 1 year, a donation of \$30,000 is required. However, SPCA also welcomes multiple sponsorships of \$1,500.00 which still come with all the benefits above
