

CRUELTY INVESTIGATION REPORT FOR THE MONTH OF JANUARY TO MARCH 2018

In the month of January, there were a total of 59 reported cases of alleged cruelty.

2 cases involving birds -

- 2 cases of birds kept in poor living conditions

10 cases involving cats -

- 3 cases of negligence
- 5 case of cat physically abused
- 1 cases of abandonment
- 1 case of suspect illegal breeding

38 cases involving dogs -

- 1 case of suspect illegal breeding
- 1 case of selling on social media
- 2 cases of negligence (left in the car)
- 4 cases of dogs caged
- 13 cases of dogs physically abused
- 5 cases of dogs kept in poor living conditions
- 7 cases of dogs left sick and untreated
- 5 cases of dogs tied up

1 case involving hamsters -

- 1 case of abandonment

- 1 case of cat left sick and untreated
- 1 case of cat kept in poor living condition

30 cases involving dogs -

- 4 cases of negligence
- 2 cases of dogs caged
- 6 cases of dogs physically abused
- 6 cases of dogs kept in poor living conditions
- 6 cases of dogs left sick and untreated
- 4 cases of dogs tied up
- 2 cases of abandonment

4 case involving hamsters -

- 2 cases of abandonment
- 1 case of hamsters kept in poor living conditions
- 1 case of negligence

2 cases involving rabbits -
