In the month of JULY there were a total of 73 reported cases of alleged cruelty.

There are 4 cases involving birds:

- 1 case of bird physically abused
- 3 cases of birds kept in poor living conditions
 - 1 case at Blk 84 Bedok North St 4 – “Fong Bird Centre”

16 cases involving cats:-

- 2 cases of cats caged
- 5 cases of cats allegedly killed/ found dead
- 3 cases of cats physically abused
- 4 cases of cats kept in poor living conditions
- 1 case of cats left sick & untreated
- 1 case of cats allowed to stray

40 cases involving dogs:-

- 1 case of dog allegedly abandoned
- 4 cases of dogs barking
- 2 cases of dog caged
- 2 cases of dogs allegedly killed/found dead
- 3 cases of dogs physically abused
- 20 cases of dogs kept in poor living conditions
- 2 cases of dogs left sick and untreated
- 1 case of dogs being trapped
- 5 cases of dogs tied up
