

**In the month of APRIL there were a total of 78 reported cases of alleged cruelty.**

**There were 49 cases involving dogs:-**

- 3 cases of dogs allegedly abandoned
- 7 cases of dogs barking
- 4 cases of dogs caged
- 6 cases of dogs physically abused
- 18 cases of dogs kept in poor living conditions
- 5 cases of dogs left sick and untreated
  - *1 case @ PLC Vivocity*
- 1 case of dog allowed to stray
- 1 case of dog tied up
- 5 cases of dogs left sick and untreated

**15 cases involving cats:-**

- 3 cases of cats allegedly abandoned
- 1 case of cat caged
- 3 cases of cats being killed/dead
- 7 cases of cats physically abused
- 1 cases of cat kept in poor living conditions

**6 cases involving rabbits:-**

- 1 case of rabbit allegedly abandoned
- 1 case of rabbit being killed/dead
- 4 cases of rabbits kept in poor living conditions

**2 cases involving birds:-**

- 1 case of bird kept in small cage
  - *1 case at Goodwill Birdshop @ Serangoon North*
- 1 case of bird trapped

**2 case involving turtle/terrapi:-**

- 1 case of turtle kept in poor living conditions
- 1 case of turtle left sick and untreated
  - *1 case @ AMB Aquatic Hub, Plaza Singapura*

**1 case involving hamster:-**

- 1 case of hamster kept in small cage

**1 case involving various pets:-**

- 1 case of various pets in a Petshop kept in poor living conditions
  - *1 case @ Pets Station, Serangoon Gardens*

**1 case involving horse:-**

- 1 case of horse kept in poor living conditions

**1 case involving guinea pig:-**

- 1 case of guinea pig kept in poor living conditions

**1 case involving hamster:-**

- 1 case of hamster kept in poor living conditions

**CRUELTY INVESTIGATION REPORT FOR THE MONTH OF MAY 2015**

**In the month of MAY there were a total of 76 reported cases of alleged cruelty.**

**There were 43 cases involving dogs:-**

- 1 case of dog allegedly abandoned
- 10 cases of dogs barking
- 2 cases of dogs caged
- 3 cases of dogs physically abused
- 3 cases of dogs allegedly killed/ found dead
- 13 cases of dogs kept in poor living conditions
- 5 cases of dogs left sick and untreated
- 6 cases of dog tied up

**15 cases involving cats:-**

- 2 cases of cats allegedly abandoned
- 3 cases of cats caged
- 2 cases of cats allegedly killed/ found dead
- 5 cases of cats physically abused
- 2 cases of cats kept in poor living conditions

**7 cases involving rabbits:-**

- 1 case of rabbit allegedly abandoned
- 6 cases of rabbits kept in poor living conditions

**4 cases involving birds:**

- 2 cases of birds kept in small cage
- 1 case of bird trapped
- 1 case of bird physically abused

**1 case involving turtle/terrapi:-**

- 1 case of turtle kept in poor living conditions

**4 cases involving hamsters, guinea pigs, rats & mice:-**

- 1 case of hamster kept in poor living conditions
- 1 case of hamster sick & untreated
  - 1 case from PLC @ Toa Payoh Central
- 1 case of rats allegedly killed/found dead
- 1 case of guinea pig allegedly abandoned

**2 cases involving fish:-**

- 1 case of fish physically abused
